1. Client agrees to pay invoice within 30 days, or incur interest charges of 1% per month.
2. Client acknowledges services are rendered at the unit rates quoted herein. Total inspection hours are as necessitated by the contractor's/client's schedule and local, state, and federal regulation requirements, and are not the responsibility of MTI.
3. In recognition of the relative risks of the Client and MTI on the project, Client agrees, to the extent permitted by law, that MTI's liability to the Client, in any way arising out of the Agreement, shall be limited to 100% of the total fees and costs paid to MTI or \$25,000, whichever is greater.
4. Client acknowledges billing minimums of 2 hours as outlined below.
5. This agreement is governed by laws of the State of Idaho and is entered into the County of Ada, City of Boise.
6. Client shall promptly pay and be responsible for the removal and lawful disposal of samples, cuttings, and hazardous substances, unless other arrangements are mutually agreed to in writing. Client shall take custody of all monitoring wells and probes during an investigation by MTI, and shall take any and all necessary steps for the maintenance, repair or closure of such wells or probes at Client's expense if so requested by MTI.
7. Services of MTI under this Agreement will be performed in a manner consistent with that level of care and skill ordinarily exercised by members of the Profession currently practicing under similar conditions in the locality of the Project. No other warranty, expressed or implied, is made.
8. If any party hereto commences an action or arbitration proceeding to interpret or enforce this contract, the prevailing party shall be entitled to an award of attorney's fees and costs in addition to all other amounts awarded by the Court of arbitrator.
9. Services provided pursuant to this Agreement are intended solely for the use and benefit of Client. No other person or entity shall be entitled to rely on the services, opinions, recommendations, plans, or specifications provided pursuant to this Agreement without the express written consent of MTI.
